

## ***RULES FOR RENT BOAT AT KROKANE CAMPING***

1. **Minimum age** – The rental of a boat is only allowed for persons who are 18 years or older.
2. **Contact number** – The tenant must provide Krokane Camping with their mobile phone number.
3. **Reception contact number** – For assistance, you can contact us at (+47) 57 75 22 50, (+47) 41 42 77 42, or (+47) 911 38 367.
4. **Phone on board** – The tenant is required to have a charged mobile phone on board at all times.
5. **Emergency numbers** – Ambulance: 113, Coastal Radio Stations: +47 120, Police: 112.
6. **No alcohol or drugs** – It is prohibited to rent a boat if the client is under the influence of alcohol, drugs, or narcotics. If intoxication is suspected, the rental can be denied.
7. **Boat and engine handling instructions** – The tenant has been instructed on the safe use of the boat and engine, including:
  - Safe movement on the boat (weight distribution, etc.).
  - Starting and using the engine.
  - Using the choke for cold starts.
  - Refueling with the fuel provided by the camping.
  - Proper use of the engine "shut-off cord" attached to a jacket or wrist for safety.
  - Checking the boat and engine for good condition prior to use.
8. **Life jackets** – Life jackets, appropriate to the weight of each passenger, are mandatory and the tenant has been trained in their use.
9. **Condition check** – Before using the boat, the tenant must check for any visible damage to the boat, engine, propeller, and other equipment. Any damage must be reported immediately before using the boat.
10. **Damage responsibility** – If the tenant damages or destroys the boat or engine, this must be reported immediately. The tenant is responsible for covering any damages. The deductible for damages is NOK 20,000, or the cost of repairs if lower.
11. **Fishing limit** – As a registered fishing center, the limit of fish that can be taken out of Norway is 20 kg per person.
12. **Reporting catches** – According to the Norwegian Directorate of Fisheries, it is mandatory to report the number of fish caught and released for selected species. For those interested in exporting fish, we offer the **FishReg** app. More information is available at the reception.
13. **Return before sunset** – The tenant must return the boat to the quay before sunset. A new trip the next day is considered a second day of rental.
14. **Weather check** – The tenant is aware that weather conditions can change and has checked the local weather report on [www.pent.no](http://www.pent.no) and **Yr.no** or **Storm.no**. These sources provide reliable, up-to-date weather forecasts for planning safe trips.
15. **Weather responsibility** – It is the tenant's responsibility to monitor the weather conditions throughout the trip.
16. **Familiarity with the area** – The tenant knows the area or has received information about the sea map, dangerous areas, and knows where they are allowed to navigate the boat. Tenants are encouraged to download an app with sea charts for reference.

- 17. Distance limits** – The boat may be used only within **3 kilometers from land**. The tenant must keep at least **100 meters** (preferably 150 meters) away from fish farms and avoid shallow areas where the propeller may be damaged.
- 18. Mooring** – At the end of the trip, the boat must be moored with at least one rope at the front and one at the back.
- 19. Boat cleanliness** – Garbage, fish waste, and blood stains from fish must be cleaned by the tenant, or they may be charged a cleaning fee of **NOK 500**.
- 20. Gutting of fish** – Fish gutting is only allowed at designated spots at Krokane Camping. Waste from gutting must be disposed of at sea, at least 150 meters from land. Alternatively, the tenant may opt for a cleaning service at an additional cost.
- 21. Fuel and life jackets return** – Fuel containers and life jackets must be returned to the designated place. Tenants must bring their own life jackets if they plan to fish. Alternatively, they may pay for cleaning of the life jackets.
- 22. Acknowledgment of safety instructions** – The tenant must sign this form to confirm that they have received and understood the safety instructions.
- 23. Penalty for engine misuse** – Starting the engine out of water (without cooling) will result in a penalty of **NOK 2000**.
